## Notes

1. A site plan showing the location and the extent of the works of demolition to a scale of not less than 1/2500 must be provided.
2. It is an offence to begin the demolition of the whole or part of a building to which Section 80 of the Building Act 1984 applies before:-

- i. Formal notice in writing under Section 80 has been given to the Council

AND

- ii. The Council has issued to the person(s) undertaking the works of demolition, a notice under Section 81.

OR

- iii. The six week period within which the Council can issue a notice has expired.

3. Section 80 applies to a demolition of the whole or a part of a building except:-

- a) A demolition in pursuance of a demolition order made under The Housing Act 1957, and

- b) A demolition:-

- i. Of an internal part of a building, where the building is occupied and it is intended that it should continue to be occupied.
    - ii. Of a building that has a cubic content (as ascertained by external measurement) of not more than 1750 cubic feet, or, where a greenhouse, conservatory, shed or prefabricated garage forms part of a larger building, of that greenhouse, conservatory, shed or prefabricated garage.

OR

- iii. Without prejudice to sub-paragraph (ii) above, of an agricultural building (as defined in Section 26 of the General Rate Act 1967), unless it is contiguous to another building of a kind mentioned in that sub-paragraph.
